## **IPET Training Program**

Beginning August 1, 2011, SMEI, LLC opened the MNRI<sup>®</sup> Intensive Professional Educational Track (IPET) for the MNRI<sup>®</sup> Core-in-Training program and for MNRI<sup>®</sup> Core Specialists who need to update required exams or who are interested in receiving intense training in one of the following listed training areas:

MNRI® IPET Tactile Integration

MNRI® IPET Dynamic and Postural Reflex Repatterning and Integration

MNRI® IPET Archetype Reflex Integration

MNRI® IPET Neuro-Structural Reflex Integration

## To start the MNRI® Intensive Professional Educational Track (IPET) the participant is required to have the following minimum requirements:

- BA, BS
- Six (6) Semester hours of training in anatomy and physiology by the time the program is completed
- Completed the MNRI<sup>®</sup> Trainee Agreement or MNRI<sup>®</sup> Core Specialist Agreement
- Completion of the MNRI<sup>®</sup> Dynamic and Postural Reflex Integration course and at least one other MNRI® Course.

The objective of the IPET training program is to provide an individualized training format, emphasizing directed hands-on training and in-depth knowledge of the MNRI® assessment and intervention strategies for each course offered. This training will offer the MNRI® Core-in-Training an opportunity to take the IPET course whenever it is offered and attend designated MNRI Family Conferences in increments of 4, 5, or 8 days. This training will provide the MNRI Core-in-Training excellent hands-on clinical training to prepare them to move into the MNRI Master's Level program, if they so wish.

The IPET Training Program offers intensive training in four basic MNRI courses, a venue to update skills and the opportunity to complete the exams/renewal exams for each listed course. This specialized training creates a pathway of education that can be completed in shorter training periods with more in-depth individual attention.

MNRI<sup>®</sup> Cores-in-Training, who take the IPET courses and attend MNRI® Family Conferences, are still required to meet all the prerequisite courses for completion of the four (4) levels of the MNRI® Core in Training program The four (4) basic IPET courses replace the 4-days of pre-conference training.

MNRI® IPET is designed for professionals who:

- Need shorter segments of training and desire to continue using the Masgutova Method<sup>®</sup> in their professional practice and use of the trademarked and intellectual property materials through a contract with the SMEI, LLC.
- Have completed all required applications, signed the MNRI<sup>®</sup> Core- in- Training Agreement, commits to signing the MNRI<sup>®</sup> Core Specialist Agreement once all training is successfully completed and meets are prerequisites.
- MNRI® Core Specialists must have signed the MNRI Core Specialist Agreement.

• The IPET, as well as the traditional levels of the MNRI® Core- in-Training program (which will be phased out in February 2013), is open to those professionals who desire to maintain a long term contractual basis with SMEI, LLC.

SMEI, LLC will be offering more 4 and 5 day MNRI Family Conferences in the coming years. MNRI<sup>®</sup> Core-in-Training Specialists, who successfully complete one or more of the IPET courses AND successfully completes

at least 64 hours of clinical/hands on supervision at a designated MNRI Family Conferences, may be eligible to work at a MNRI Family Conference.

To register for any of the IPTE courses, the participant must have successfully completed the specific MNRI Course (Tactile, Archetype, Dynamic and Postural-Twice, Neuro-Structural) <u>before</u> signing up for the specific IPET course.

MNRI® Cores- in-Training are still required to meet all the prerequisite courses and clinical/hands on supervision hours for completion of the four (4) levels of the MNRI® Core in Training program. This includes the completion of eleven (11) MNRI courses <u>plus</u> four (4) IPET courses, and attendance at MNRI Family Conferences for a total of to 304 hours of Core- in- Training conference time and 128 hours of preconference or IPET training.

Participants in the IPET Training Program will be charged \$75.00 per day for Clinical/Observational Supervision at the MNRI Family Conferences. The conference must attend in increments of 4, 5 or 8 days at a MNRI Family Conference that Dr. Masgutova is directing.
