## **MNRI® INSTRUCTOR/LECTURER STUDENT TEACHER PROGRAM REQUIREMENTS**

- A. MNRI® Student Teacher meets all requirements of full MNRI® Core Specialist and maintains recertification requirements each two years.
- B. MNRI® Student Teacher must have at least a Master's degree or 10 years of professional experience and personal invitation from Dr. Masgutova and Pamela Curlee.
- C. MNRI® Student Teacher must be personally invited to begin the MNRI® Instructor Student Teaching program by Dr. Masgutova and Pamela Curlee.
- D. MNRI® Student Teacher for the Instructor's Program must have all required paper work in to the SMEI, LLC before any Student Teaching requirements will count towards completion of program. [\(Click to go to application\)](#)
- E. MNRI® Student Teacher must have approval by the LLC of the designated MNRI® Instructor before the student teaching time will count towards completion of requirements. This means the Student Teacher gets pre-approval of MNRI® Instructor before student teaching.
- F. MNRI® Student Teacher may provide lectures for parents and professionals in any country where MNRI® Family Educational Conferences are being offered and with a written request from the Conference organizer. **May be invited** to provide lectures and/or instruction at Pre-conference courses at MNRI® Educational Family Conference as selected by the Conference organizer.
- G. MNRI® Student Teacher must abide by the MNRI® Code of Ethics and Conduct

### **Requirements for Student Teacher:**

#### **MNRI® Dynamic and Postural Reflex Integration And Neuro Structural Reflex Integration**

- Must take the Dynamic and Postural Reflex Integration or Neuro Structural Reflex Integration course at least twice.
- Must demonstrate excellent skills as an Instructor in general and be requested by Dr. Masgutova and Pamela Curlee to begin Student Teacher for this course. • Must have received excellent evaluations on the IPET Dynamic and Postural Reflex Integration course or the IPET Neuro Structural Reflex Integration course. • Must student-teach this course at least three times with a current Dynamic and Postural or Neuro Structural Reflex Integration Instructor pre-approved designated by Dr. Masgutova or Pamela Curlee before the student teaching occurs. It is understood that the applicant may be required to student teach unspecified additional times until the required skills are demonstrated as listed on

the evaluation form.

- The last student teaching experience must be completed with one being either Pamela Curlee or Dr. Masgutova.
- Must receive excellent evaluation from the MNRI<sup>®</sup> Instructor of the course and course participants. **(Click to download evaluation form).**
- The first three student-teach opportunities will require a registration fee of 50% of the course fee. If the Instructor Student Teacher is required to student-teach for more than three times the course registration fee is waived.
- The student teacher must register for the course at least 24 days before the course begins with the designated MNRI<sup>®</sup> Instructor of the course.
- Attend the MNRI<sup>®</sup> Master's Level 1 and Level 2 Course at least once.

### **MNRI<sup>®</sup> IPET Courses**

- Must take the specific MNRI<sup>®</sup> IPET Course at least twice with excellent scores on end of course exams.
- Must student-teach this course at least twice with a current Instructor designated by Dr. Masgutova or Pamela Curlee.
- Must receive excellent evaluation from the MNRI<sup>®</sup> Instructor of the course and course participants. **(Click to download evaluation form).**
- Must be approved as an Instructor for this IPET Course by Dr. Masgutova and Pamela Curlee.
- The first two student-teach opportunities will require a registration fee of 50% of the course fee. If the Instructor Student Teacher is required to student-teach for more than two times the course registration fee is waived.
- The student teacher must register for the course at least 24 days before the course begins with the designated MNRI<sup>®</sup> Instructor of the course.
- Attend the MNRI<sup>®</sup> Master's Level 1 and Level 2 Course at least once.

### **All other MNRI<sup>®</sup> Courses**

- Must take the specific MNRI<sup>®</sup> course at least twice
- Must student-teach this course at least twice with a current Instructor who has been designated by Dr. Masgutova or Pamela Curlee.
- Must receive excellent evaluation from the MNRI Instructor of the course and course participants. **(Click to download evaluation form).**
- Must be approved as an Instructor for this course by Dr. Masgutova and Pamela Curlee.
- The first two student-teach opportunities will require a registration fee of 50% of the course fee. If the Instructor Student Teacher is required to student-teach for more than two times the course registration fee is waived.
- The student teacher must register for the course at least 24 days before the course begins with the designated MNRI<sup>®</sup> Instructor of the course.
- Attend the MNRI<sup>®</sup> Master's Level 1 and Level 2 Courses at least once.

**Once all above requirements have been met:**

1. MNRI® Student Teacher Must sign the MNRI® Independent Contract with the Svetlana Masgutova Educational Institute®, LLC as a MNRI® Instructor /Lecture Level for the right to teach the MNRI® specific course (s) once completion of all required training has been approved by the appropriate LLC representatives.
2. MNRI® Student Teacher submits copy of active professional liability insurance minimum of 1,000,000/3,000,000 level **and** provides the following from their professional insurance company: ACORD, Evidence of Insurance, or Memorandum of Insurance.
3. MNRI® Instructor must instruct at least Three (3) courses for each Course under MNRI® contract each year with a total of at least 18 participants.
4. MNRI® Instructor must maintain MNRI Membership **at the Core Specialist level.**
5. MNRI® Instructor Teacher must abide by the MNRI® Code of Ethics and Conduct **(Click to download Code of Ethics and Conduct).**
6. MNRI® Instructor will receive free advertising on the SMEI, LLC website for all MNRI® events submitted 6 weeks before the event.
7. MNRI® Instructor may contract with the SMEI, LLC to sponsor MNRI® Boot Camp for Parents/Families (or similar activity).
8. MNRI® Instructor recertification as a MNRI® Instructor is required every two years. The recertification requirements include:
  - Attendance of at least one MNRI® Family Educational Conference of at least 40 hours every two years. MNRI® Instructor may be asked by SMEI, LLC to repeat and pass any designated test of competency.
  - Maintain and follow the MNRI® Code of Ethics and Conduct in relationships with families and co-workers.
  - Honors and protects the Masgutova trademark and the exclusive rights of the SMEI, LLC to set up Family Educational Conferences.
  - Complete at least 64 hours of MNRI® course work.
9. If MNRI® Instructor has not taught a specific class in 5 years, they will need to retrain and complete an in-person/hands-on exam on the materials before they can teach the class again.
